2. The expenditure shall be shared equally by State Government of Madhya Pradesh and Ministry of Railways (West Central Railway). Accordingly, Railway's share towards the cost of 71 posts will be restricted to 50% of the yearly expenditure of approximately Rs. 2,42,57,448/- (Rs. Two Crore Forty Two Lakhs Fifty Seven Thousand Four Hundred and Forty Eight only). However, the actual amount may be ascertained in consultation with Principal Financial Advisor before releasing the payment to the Government of Madhya Pradesh.

3. It shall be ensured that the Railway will bear the share of its cost only from the date of sanction of this order.

4. The expenditure would be chargeable to Demand No. 80-Major Heads 3002 & 3003-Sub Major Head 10- Misc. Working Expenses and should be met out of the West Central Railway's funds.

5. This issues with the concurrence of Finance Directorate of the Ministry of Railways.
